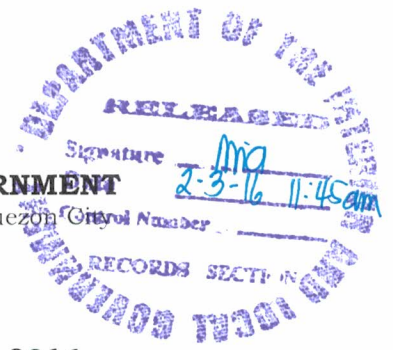

SUBJECT : ATTENDANCE TO THE 2016 NATIONAL ASSEMBLY OF THE LIGA  
NG MGA BARANGAY SA PILIPINAS (LnB) CUM FORUM ON  
BOTTOM-UP BUDGETING (BuB)

The Liga ng mga Barangay sa Pilipinas (LnB) will hold its 2016 National Assembly cum Forum on Bottom-Up Budgeting on February 10-12, 2016 at the Philippine International Convention Center (PICC), Vicente Sotto Street, CCP Complex, Pasay City.

The highlight of the activity will be the Launching of the Barangay Bottom-Up Budgeting (BuB). Mechanics of implementation and selection criteria in choosing the recipient barangays will be presented, and related reform initiatives at the barangay will also be discussed.

In this connection, through the request of Hon. Carlos C. Abesamis, Acting Executive Director, LnB-National, all Regional/Provincial/City/Municipal LnB Chapter Presidents, Barangay Officials and Members, are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-National President shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said assembly.

All DILG Regional Directors and Field Officers are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
