# RESOLUTION ADOPTING THE IATF RESOLUTION NO. 117 MANDATING THE LGUS TO ADOPT THE DICT VACCINE ADMINISTRATION SYSTEM (D-VAS)

- WHEREAS, the IATF-MEID issued Resolution No. 95 dated January 21, 2021 approving the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). It recognizes the vital role of the LGUs in the success of the National Vaccination Program;
- WHEREAS, the IATF-MEID released Resolution No. 117 dated May 27, 2021 which mandated the LGUs to adopt and utilize the Department of Information and Communications Technology Vaccine Administration System (D-VAS) without prejudice to their existing local database system. The system aims to ease the process in generating vaccine cards for the smooth implementation of the vaccination program through the LGUs;
- **WHEREAS,** DILG issued Memorandum dated June 21, 2021 requiring the LGUs to provide baseline data on the use of D-VAS or any other similar systems;
- WHEREAS, DICT Mindanao Cluster conducted D-VAS Roadshow to the LGUs of Region 12 on June 15, 16 and 22, 2021 to orient them of the system and the necessary requirements to be submitted to jumpstart its adoption. As of June 29, 2021, only the City of Tacurong and the Municipality of Columbio submitted the complete documents and are now ready for technical assistance of DICT-Mindanao Cluster;
- **NOW, THEREFORE,** on motion of RD Teresita Socorro C. Ramos of NEDA XII and jointly seconded by RD Macario D. Gonzaga of LTO XII and RD Servillano Santiago Lorenzo III of DOJ-PAO XII; **BE IT RESOLVED,** as it is hereby resolved, to Adopt the IATF-MEID Resolution No. 117 Mandating the LGUs to Adopt the DICT Vaccine Administration System (D-VAS);
- **RESOLVED FURTHER,** that a copy of this Resolution be forwarded to the IATF-MEID and NTF COVID-19 for their information. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all

Local Government Units of Region XII for their information and appropriate action.
