RESOLUTION NO. 2021-13D

RESOLUTION REQUESTING THE LGUs OF REGION 12 TO IDENTIFY MORE VACCINATION SITES AND LOBBY FOR SUPPORT FROM ALL SECTORS IN IMPLEMENTING THE VACCINATION PROGRAM

WHEREAS, the IATF-MEID issued Resolution No. 95 dated January 21, 2021 approving the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). The plan adopts the whole-of-government and whole-of-society approach. As such, government agencies are enjoined to coordinate with the CSOs, private groups, media men and other stakeholders for the smooth implementation of the program;

WHEREAS, DILG issued Memorandum Circular 2021-07 dated January 18, 2021 enjoining the LGUs to prepare their vaccination plans. Specifically, the LGUs are mandated to prepare their risk communication plan, master list of priority of eligible vaccinee population, list of designated vaccine centers, cold chain storages and other logistical requirements; master list of human resources and personnel for the program; and reorganized EOC dedicated for vaccine concerns, among others;

WHEREAS, the LGUs, being at the frontline of COVID-19 disaster response, are expected to fast track the implementation of vaccination program to ensure community herd immunity against the virus;


WHEREAS, the Body recognizes that the expansion of vaccination sites will ease the queueing system and will facilitate more active support of the constituents to participate to the vaccination program;


NOW, THEREFORE, on motion of RD Teresita Socorro C. Ramos of NEDA XII and seconded by RD Macario D. Gonzaga of LTO XII; **BE IT RESOLVED**, as it is hereby resolved, to Request the LGUs of Region 12 to Identify More Vaccination Sites and Lobby for Support from All Sectors in Implementing the Vaccination Program;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and support. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all Local Government Units of Region XII for their immediate and appropriate action.
