RESOLUTION NO. 2021-14A

July 14, 2021

RESOLUTION URGING ALL LGUs OF REGION 12 TO INTENSIFY THE REGULAR ROUTINE IMMUNIZATION ON PREVENTABLE DISEASES IN THEIR RESPECTIVE JURISDICTION WHILE COVID-19 CASES ARE DECLINING

WHEREAS, IATF-MEID has released Resolution No. 124 which classified the Province of Cotabato under Modified General Community Quarantine (MGCQ) while the remaining parts of the Region under General Community Quarantine (GCQ) effective July 1, 2021;

WHEREAS, DOH-CHD XII reported that as of June 13, 2021, the Region has a total of 24,111 confirmed cases of whom 20,276 have fully recovered, 766 deaths and 3,065 are currently under quarantine or confined in the referral hospitals. An average of 213 cases was recorded in a span of seven days;

WHEREAS, the LGUs through its Local Health Offices are currently implementing the COVID-19 vaccination program in order to quickly achieve the herd immunity against the virus, however there should be continuity on massive immunization for other diseases such as bacilli calmette-guerin (BCG), measles-mumps-rubella vaccine (MMR), pneumococcal conjugate vaccine (PCV), diphtheria, tetanus toxoids and pertussis vaccine (DTP), oral polio vaccine (OPV), inactivated poliovirus vaccine (IPV), hepatitis B and human papillomavirus vaccine (HPV);

WHEREAS, DOH-CHD XII has issued an Advisory dated June 25, 2021 reiterating to LGUs and the Local Health Officers to regularly submit their National Immunization Program (NIP) reports and implement catch-up activities to avoid outbreaks of Vaccine-Preventable Diseases;


NOW, THEREFORE, on motion of RD Aristides Concepcion Tan of DOH-CHD XII and seconded by ARD Jerome Barranco of OCD XII; **BE IT RESOLVED**, as it is hereby resolved, Urging all LGUs of Region 12 to Intensify the Regular Routine Immunization on Preventable Diseases in their Respective Jurisdiction while COVID-19 Cases are Declining;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, and NTF COVID-19 for their information and support. The same copy shall be

furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all Local Government Units of Region XII for their immediate and appropriate action.


