RESOLUTION NO. 2021-16A

**RESOLUTION REITERATING THE ADOPTION AND USE OF S-PASS FOR ALL TRAVELERS
BY LGUs OF REGION 12 THAT ARE NOT YET IMPLEMENTING IT**

WHEREAS, IATF-MEID has released Resolution No. 130-A which classified the entire Region under General Community Quarantine (GCQ) effective August 1, 2021 until August 31, 2021;

WHEREAS, DOH-CHD XII reported that as of August 10, 2021, the Region has a total of 30,017 confirmed cases of whom 25,944 have fully recovered, 972 deaths and 3,096 are currently under quarantine or confined in the referral hospitals. An average of 236 cases was recorded in a span of fourteen days;

WHEREAS, DOST has developed the Safe, Swift and Smart Passage or S-PaSS as an innovative travel management system for local travelers who are returning to or visiting different localities for vacation or for official business. The travel management system allows local travelers to access information on travel restrictions imposed by different LGUs due to COVID-19 pandemic;

WHEREAS, IATF-MEID Resolution No. 101 dated February 26, 2021 required the institutionalization of DOST S-PaSS to the LGUs as the one-stop-shop application/communication for travelers;

WHEREAS, DOST XII reported that as of August 10, 2021, all of the Provinces are using the S-PaSS while General Santos City is yet to utilize the system. All of the component cities and municipalities were also given access to the platform but there are still 38 out of 48 LGUs which need to log-in their data as to travel restrictions;

WHEREAS, the Body believes that DOST-SPaSS implementation in LGUs of Region 12 will address the concerns on travel restrictions while ensuring that health protocols are observed by the local travelers;


NOW, THEREFORE, on motion of Gov. Steve C. Solon of Sarangani Province and jointly seconded by ARD Jerome Barranco of OCD XII and RD Aristides Concepcion Tan of DOH-CHD XII; **BE IT RESOLVED**, as it is hereby resolved, to Reiterate the Adoption and Use of S-PASS for All Travelers by LGUs of Region 12 that are not yet Implementing it;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19 and members of RIATF EID XII and RTF COVID-19 XII for their information and support. The same copy shall be furnished to concerned LGUs for their information and appropriate action.


