RESOLUTION NO. 2022-03

January 12, 2022

RESOLUTION URGING THE LOCAL GOVERNMENT UNITS OF REGION XII TO CONSIDER THE ENACTMENT OF AN ORDINANCE FOR MOBILITY RESTRICTIONS AMONG UNVACCINATED INDIVIDUALS

- WHEREAS,** on March 9, 2021, President Rodrigo Duterte issued Proclamation No. 922, declaring the entire country under a State of Public Health Emergency due to COVID-19 pandemic;
- WHEREAS,** at the start of the year, an upsurge in positive cases for COVID-19 has been observed due to the Omicron variant particularly in the National Capitol Region;
- WHEREAS,** the developments in our public health and economic gains that have been achieved in the last quarter of 2021 under Alert Level 2 need to be sustained with vigilance and pre-emptive measures to immediately address the perceived threat of a highly-transmissible Omicron Variant and its adverse impacts;
- WHEREAS,** with the series of vaccination drives in the Region, the DOH-CHD XII reported that, as of January 11, 2022, SOCCSKSARGEN Region has a target population of **3,490,115**. Of these target population, only **1,815,476** or **(52.01%)** are fully vaccinated, around **1,213,403 (34.77%)** are still unvaccinated (partially



vaccinated, missed second doses), and only **71,279** received their booster doses;

WHEREAS, despite the availability of vaccines, there are a number of individuals and group of individuals who refused to be vaccinated; hence, they become more susceptible to COVID-19 infection which require hospitalization; hence resulting to the over burdening our health care system, declaration of granular lockdowns by some LGUs, and possible heightened Alert Level status;

WHEREAS, On January 2, 2022, the Metropolitan Manila Development Authority (MMDA) issued a Resolution urging the Metro Manila local government units to enact their respective ordinances on the enhanced restrictions of the vaccinated individuals to regulate their mobility in the National Capital Region while the COVID-19 alert level in the NCR is at Alert Level 3 or higher;

WHEREAS, the League of Provinces of the Philippines (LPP) issued its Memorandum dated January 3, 2022 urging Provincial Governors to “issue local policies in a form of an Executive Order or Sangguniang Panlalawigan Resolution, regulating the mobility of unvaccinated individuals”;

WHEREAS, on December 24, 2021, the IATF issued the latest Guidelines on the Nationwide Implementation of Alert Level System for COVID-19 Response on December 14, 2021 after the Executive Order No. 151 was signed by President Rodrigo R. Duterte, which includes the mobility of vaccinated and unvaccinated individuals in all alert level systems;

WHEREAS, Section 4 (g) of Republic Act 11449 provides that “all local government units are acting within the letter and spirit of all the rules, regulations, and directives issued by the National Government pursuant to this Act; are implementing standards of community quarantine consistent with what the National Government has laid down, while allowing LGUs to continue exercising their autonomy in matters undefined by the National Government or are within the parameters it has set; and are fully cooperating towards a unified, cohesive, and orderly implementation of the national policy to address COVID-19”;

NOW THEREFORE, on unanimous sponsorship of the RIATF-EID XII and RTF XII members present; **BE IT RESOLVED,** as it is hereby **RESOLVED,** to **URGE THE LOCAL GOVERNMENT UNITS OF REGION XII TO CONSIDER THE ENACTMENT OF AN ORDINANCE FOR MOBILITY RESTRICTIONS AMONG UNVACCINATED INDIVIDUALS.**



RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of the RIATF-EID XII and RTF-COVID-19 XII for their information. Same Resolution be forwarded all local government units of Region XII for their information and appropriate action.
