**RESOLUTION NO. 2022-10**

*January 31, 2022*

**RESOLUTION ENCOURAGING THE LGUS OF REGION XII TO ALLOW THE USE OF REGIONAL EVACUATION CENTERS AS VACCINATION SITES**

- WHEREAS,** Section 15 Article II of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;
- WHEREAS,** on September 10, 2021, the President issued Proclamation No. 1218 series of 2021, further extending the period of the State of Calamity throughout the Philippines until September 12, 2022, unless earlier lifted as circumstances may warrant or extended due to the public's failure to comply with minimum health protocols and sudden spike of new COVID-19 cases in the country;
- WHEREAS,** during the 'Talk to the People of President Rodrigo Roa Duterte' on January 24, 2022, the COVID-19 response was discussed putting premium to the National COVID-19 Vaccination Program;
- WHEREAS,** per the Department of Health National COVID-19 Vaccination Dashboard, as of January 31, 2022, about 60,423,247 Filipinos received their 1<sup>st</sup> Dose, 59,026,198 received their 2<sup>nd</sup> Dose, and 7,502,082 received their Booster Dose;
- WHEREAS,** during the Joint Meeting of the Joint RIATF-EID XII and RTF XII on January 31, 2022, the DOH-CHD XII reported that, as of January 30, 2022, SOCCSKSARGEN Region has a target population due for vaccination of **3,490,115**. Of these, **2,089,219** are fully vaccinated or **(59.86%)** higher than the reported **52.01%** on January 11, 2022. Currently, there are around **1,082,730** or **(31.02%)** are still unvaccinated (partially vaccinated, missed second doses);
- WHEREAS,** according to the National Task Force on COVID-19, the National COVID-19 Vaccination Program will continue, and the inoculation of 5-11 years old will commence to be pilot-run in the National Capital Region utilizing both hospitals and non-hospitals;
- WHEREAS,** the expansion of eligible vaccination to 5 to 11 years old require a more strategic vaccination roll-out plan including the establishment of dedicated



facilities to avoid overcrowding and the possible risk of COVID-19 infection among them;

**WHEREAS,** on January 26, 2022, the Office of Civil Defense has issued Memorandum No. 047, series of 2022 enjoining all Regional Task Forces (RTFs) for COVID-19, to set up vaccination facilities in evacuation sites and coordinate with Local Task Forces to ensure that vaccines and other commodities are available on all evacuation centers;

**WHEREAS,** considering that evacuation centers are located, maintained, and managed by the local government units, the Body finds it essential to encourage the LGUs of Region XII to allow the use of the Regional Vaccination Centers as vaccination sites;


**NOW, THEREFORE,** on motion of ARD Jerome S. Barranco of OCD XII and seconded by ARD Sulpicio Henry M. Legaspi, Jr. of DOH-CHD XII; **BE IT RESOLVED,** as it is hereby **RESOLVED,** to **ENCOURAGE THE LGUS OF REGION XII TO ALLOW THE USE OF REGIONAL EVACUATION CENTERS AS VACCINATION SITES**

**RESOLVED FURTHER,** that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of the RIATF-EID XII and RTF-COVID-19 XII for their information. The same Resolution shall also be furnished to all local government units of Region XII for their information and immediate action.


