RESOLUTION NO. 2022-11
January 31, 2022

RESOLUTION ENJOINING THE LOCAL GOVERNMENT UNITS OF REGION XII TO DESIGNATE DATA MANAGERS TO ADDRESS THE REQUESTS OF INDIVIDUALS ON THE RECTIFICATION OF THEIR RECORDS IN THE VAXCERTPH AND HIRE ADDITIONAL MANPOWER FOR THE UPDATING OF VAS LINE LIST

- WHEREAS,** Republic Act No. 11525 also known as the COVID-19 Vaccination Program Act of 2021 mandates DOH through local government units and other key offices, to issue COVID-19 vaccine cards to all persons vaccinated in the Philippines, subject to the provisions of RA 10173 or the *"Data Privacy Act of 2012"*;
- WHEREAS,** DICT has developed a digital verification process of vaccination known as **VaxCertPh** sometime in August 2021; the application is a self-service portal that pulls vaccination data from a line list record submitted by local government units and stored in a VIMS database;
- WHEREAS,** Joint Administrative Order No. 2021-001 between DOH, DICT, DFA, DILG, DOTr, DOT, and DOLE provides the general policy on the digital vaccination certificate or VaxCertPH which provides, among others, "the accurate encoding of personal and vaccination details of each vaccinee in the format consistent to the guidelines promulgated by DOH" within the jurisdiction of each LGU;
- WHEREAS,** during the Joint Meeting of the RIATF-EID XII and RTF XII on January 31, 2022, DICT Mindanao Cluster reported that as of January 28, 2022, the VAS Line List Compliance of Region XII is at 74.35% with a -1,159,706 backlog. DICT also reported that there are considerably duplicate records in the VIMS as compared to the number of actual vaccines administered;
- WHEREAS,** DILG Memorandum Circular No. 2021-095 enjoins the Local Government Units, being at the frontline in the implementation of the vaccination program, to establish at least one (1) VaxCertPH booth to provide means to vaccinated individuals with little to no technological access/knowledge in generating their Digital Vaccination Cards (DVCs), as well as perform the validation and rectification process. Further, they are mandated to provide manpower resources (VaxCertPh Designate/Point Person) responsible to generate DVCs to booth-goers, assist in the validation and rectification of incorrect or no record found cases, and coordinating with Contact Centers regarding the status of submitted requests;



WHEREAS,

foregoing premises considered, the Body finds it essential to ensure the encoding and issuance of verified vaccination certificates, hence, local government units must ensure the hiring of competent manpower to accommodate the requests of all individuals in the issuance of their vaccination certificates and/or rectification of their COVID-19 vaccination records;


NOW, THEREFORE, on motion of RD Usman J. Akmad of DBM XII and seconded by RD Teresita Socorro C. Ramos of NEDA XII; **BE IT RESOLVED,** as it is hereby **RESOLVED,** to **ENJOIN THE LOCAL GOVERNMENT UNITS OF REGION XII TO DESIGNATE DATA MANAGERS TO ADDRESS THE REQUESTS OF INDIVIDUALS ON THE RECTIFICATION OF THEIR RECORDS IN THE VAXCERTPH AND HIRE ADDITIONAL MANPOWER FOR THE UPDATING OF VAS LINE LIST**

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of the RIATF-EID XII and RTF-COVID-19 XII for their information. The same Resolution is forwarded to all local government units of Region XII for their information and immediate action.


