RESOLUTION NO. 2021-12A

June 16, 2021

RESOLUTION URGING THE LGUs OF REGION 12 TO PRIORITIZE THE PROVISION OF FUNDS FOR THE CONSTRUCTION AND OPERATIONALIZATION OF A STANDARD LGU-RUN ISOLATION FACILITY FOR COVID-19 PATIENTS WHO ARE UNDERGOING ISOLATION

WHEREAS, the President in a press conference on June 15, 2021 has announced that SOCSKSARGEN Region will be under General Community Quarantine (GCQ) from June 16 to 30, 2021. Further, the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated May 20, 2021 provided for the minimum protocols to be observed in areas under the GCQ status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; and the movement of all persons shall be limited to accessing essential goods and services, from permitted establishments, for work in such establishments xxx;

WHEREAS, DOH-CHD XII reported that as of June 15, 2021, the Region has a total of 16,679 confirmed cases of whom 12,812 have fully recovered, 480 deaths and 3,385 are currently under quarantine or confined in the referral hospitals. An average of 297 cases a day was recorded in the last fourteen days;

WHEREAS, DILG as early as February 6, 2020 has issued Memorandum Circular 2020-023 otherwise known as the Guide to Action Against the 2019 Novel Coronavirus Acute Respiratory Disease. One of the many roles and responsibilities stipulated in the directive is for the LGUs to identify and designate appropriate place that will serve as the Barangay Isolation Unit (BIU) for those who have travel history from areas with COVID-19 cases and are manifesting symptoms. The BIU must be an enclosed but well-ventilated structure with walls, windows and doors. It must be equipped with appropriate furniture and beds and with sufficient provision of electricity and running water, a kitchen, toilet and bath;

WHEREAS, DOH has released Department Memorandum No. 2020-0270-A on October 29, 2020 which sets the Guidelines in the Certification of LIGTAS COVID-19 Community Isolation Units. The directive sets the standards and requirements for LIGTAS COVID-19 Centers as to physical plant, human resources, equipment, supplies and other resources;

WHEREAS, DILG and DBM Joint Memorandum Circular 2020-02 dated March 30, 2020 enumerates the Provisional Guidelines on the Preparation and Approval of the Annual Investment Programs of Local Government Units In View of the Coronavirus Disease 2019 (COVID-19) Situation. The LGUs may utilize their local fund for COVID-19 related PPAs and expenses provided that these are part of their approved AIPs;

WHEREAS, the continued increasing trend of COVID-19 cases in the Region demands for expansion and improvement of existing facilities to ensure that all COVID-19 patients and their close contacts are isolated immediately while waiting for the result of their RT-PCR test and complying with the mandatory quarantine protocols.

NOW, THEREFORE, on motion of PSR Ronan Eugene C. Garcia of MEDAFC, RDC XII and seconded by RD Macario D. Gonzaga of LTO XII; **BE IT RESOLVED**, as it is hereby resolved, to Urge the LGUs of Region 12 to Prioritize the Provision of Funds for the Construction and Operationalization of a Standard LGU-Run Isolation Facility for COVID-19 Patient who are Undergoing Isolation;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and support. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all Local Government Units of Region XII for their immediate and appropriate action.
