(LnB) REGIONS I AND II, 1ST SOLID NORTH UNIFIED

**BARANGAY CONGRESS** 

The Liga ng mga Barangay sa Pilipinas (LnB) – Regions I and II will hold its 1st Solid North Unified Barangay Congress at the SMX Convention Center, Mall of Asia, Pasay City on March 13 to 15, 2019, with the theme, "1Barangay: Matuwid na Pamamaraan Tungo sa Isang Tunay na Pagbabago."

In this connection, through the request of Hon. Mario Subagan, President, Liga ng mga Barangay Region I and Hon. Victor Gines, President, Liga ng mga Barangay Region II, all Punong Barangays of Regions I and II, are hereby encouraged to participate in the said activity, on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized, chargeable against the barangay funds, subject to the availability hereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-Presidents for Regions I and Region II shall submit within one (1) month after the conduct of the Congress, a Post-activity Report to the Undersigned, through the National Barangay Operations Office, reflecting the following:

- 3. Venue
- 4. No. of Pax

- 5. Objectives of the Activity
- 6. Highlights of the Activity
- 7. Output/s
- 8. Attachments, if any.

All DILG Regional Directors and Field Officers in Regions I and II are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
