WHEREAS, DOH-CHD XII reported that as of October 27, 2020, the Region has a total of 2,578 confirmed cases of whom 1,802 have fully recovered, 78 deaths and 697 are currently under quarantine or confined in the referral hospitals. A total of 389 cases was added in a span of seven days or an average of 56 cases per day;

WHEREAS, NTF Against COVID-19 Order No. 2020-02 entitled, "Operational Guidelines on the Management of Locally Stranded Individuals" mandates the LGUs, being at the frontline of the management and response to COVID-19, to organize the Sub-Task Group on Management of Returning Overseas Filipinos and Locally Stranded Individuals (STG on Management of ROFs and LSIs) under their Local COVID-19 Task Forces.

WHEREAS, the STG on Management of ROFs and LSIs is tasked to facilitate the repatriation and provide assistance to ROFs and LSIs especially in transporting them from the various entry points of Mindanao to isolation areas 24hours in 7days a week;

- January 1, 2021



**POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF
CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12**

WHEREAS, per Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated October 22, 2020, the IATF approved the minimum protocols to be observed by areas under the Modified General Community Quarantine status. Specifically, Section 5 requires the strict implementation of the following:

- *Minimum public health standards shall be complied with at all times for the duration of MGCQ; and*
- *The movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder, and for other activities permitted under this Section;*

WHEREAS, DOH-CHD XII reported that as of October 27, 2020, the Region has a total of 2,578 confirmed cases of whom 1,802 have fully recovered, 78 deaths and 697 are currently under quarantine or confined in the referral hospitals. A total of 389 cases was added in a span of seven days or an average of 56 cases per day;

WHEREAS, DepEd, in pursuant to the instruction of President Rodrigo Roa Duterte, suspended the opening of classes among public schools from August 24, 2020 to October 5, 2020. Further, to ensure continuity of learning among students and safety of the learners and teachers, both public and private schools were prohibited to implement face-to-face classes;

WHEREAS, DepEd Office Memoranda Nos. 2, 3, 4 and 5 series of 2020, allow the LGUs to use the public schools as quarantine or isolation areas for COVID-19 provided that the following requirements are met:

- *Documents to prove that all other facilities were assessed but were found inadequate;*
- *Assessment result from local officials stating that the identified school is suitable for intended purpose (LHO for health related, LSWDO for welfare related); and*
- *DILG certification which attest that all activities to be conducted in schools are within the parameters set by the National Government;*

WHEREAS, NTF Against COVID-19 Order No. 2020-02 entitled, “Operational Guidelines on the Management of Locally Stranded Individuals” mandates the LGUs, being at the frontline of the management and response to COVID-19, to organize the Sub-Task Group on Management of Returning Overseas Filipinos and Locally Stranded Individuals (STG on Management of ROFs and LSIs) under their Local COVID-19 Task Forces. The group is tasked to facilitate the repatriation and provide assistance to ROFs and LSIs especially in transporting them from the airports/seaports to isolation areas 24/7 a week;

WHEREAS, during the 23rd Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate or future actions to avoid the further spreading of the virus;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 approved the following Resolutions:

- A. RESOLUTION FAVORABLY INDORSING TO NTF-COVID-19 AND IATF-EID THE REQUEST OF SURALLAH, SOUTH COTABATO FOR THE MORATORIUM OF THE ENTRY OF LSIs ON DECEMBER 24, 25, 31 AND JANUARY 1, 2021;
- B. RESOLUTION APPROVING THE REQUEST OF LGU-KIDAPAWAN CITY, PROVINCE OF COTABATO TO EXTEND THE USE OF DepEd SCHOOLS AS ADDITIONAL QUARANTINE FACILITIES UNTIL DECEMBER 2020;
- C. RESOLUTION APPROVING THE NEW SCHEDULE OF JOINT RIATF-RTF ON COVID-19 MEETINGS TO TWICE A MONTH EFFECTIVE NOVEMBER 2020; AND
- D. RESOLUTION REQUESTING NTF-COVID-19 AND IATF-EID TO ALLOW THE MORATORIUM OF THE ENTRY OF LSIS TO REGION-12 LGUS ON DECEMBER 24, 25, 31, AND JANUARY 1, 2021


