**RESOLUTION NO. 2020-037-A**

**RESOLUTION REQUESTING THE LAW ENFORCEMENT AUTHORITIES TO CONDUCT SCANNING  
OF REGION 12's CONTACT TRACING SYSTEM (RCCTS)  
I.D. IN ALL BORDERS OF REGION XII**

**WHEREAS**, per Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated October 22, 2020, the IATF approved the minimum protocols to be observed by areas under the Modified General Community Quarantine status. It specifically requires the strict implementation of the following:

- *Minimum public health standards shall be complied with at all times for the duration of MGCQ; and*
- *The movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx;*

**WHEREAS**, DOH-CHD XII reported that as of November 10, 2020, the Region has a total of 3,252 confirmed cases of whom 2,487 have fully recovered, 105 deaths and 659 are currently under quarantine or confined in the referral hospitals. A total of 326 cases was added in a span of seven days or an average of 47 cases per day;

**WHEREAS**, DILG MC 2020-077 mandates the LGUs to organize a Contact Tracing Team under the Local COVID-19 Task Force. The team is tasked to conduct contact tracing to all persons with known exposure to a COVID-19 patient;

**WHEREAS**, the LGUs, being at the frontline in managing the COVID-19 pandemic, have initiated various web-based and mobile-based contact tracing applications to expedite the identification of the close contacts of the confirmed COVID-19 patients;

**WHEREAS**, the Joint RIATF-EID XII and RTF COVID-19 has approved the following policies to ensure the harmonization of contact tracing efforts of all LGUs in the Region:

- *Resolution Institutionalizing the South Cotabato COVID-19 Contact Tracing System (SC-CCTS) As Region 12's COVID-19 Contact Tracing System dated August 26, 2020; and*
- *Resolution Appealing to all LGUs of Region 12 to Adopt the Region 12's Contact Tracing System (RCCTS) As One Application to Ensure Interoperability and Convenience of Contact Tracing Efforts dated October 7, 2020;*

**WHEREAS**, the scanning of R-12's CCTS in the borders will maximize its use and will serve as information and education campaign to increase appreciation of both residents and non-residents of the system;


**NOW, THEREFORE**, on motion of PSR Ronan Eugene C. Garcia of MEDAFC, RDC XII and seconded by PSR Rolando S. Doria of RSDC, RDC XII; **BE IT RESOLVED**, as it is hereby resolved, to Request the Law Enforcement Authorities to Conduct Scanning of Region 12's Contact Tracing System (RCCTS) I.D. in All Borders of Region XII;

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19, Provincial Governors, City and Municipal Mayors of Region XII, and members of RIATF-EID XII & RTF COVID-19 for their information and/or appropriate action. The same copy shall be forwarded to PNP XII for their strict enforcement in the borders of the Region.


