**RESOLUTION NO. 2020-016-B**

June 10, 2020

**RESOLUTION REQUESTING IATF TO EXTEND REGION 12's REGIONAL BORDER LOCKDOWN  
UNTIL JUNE 30, 2020**

**WHEREAS**, Item 1 of IATF Resolution No. 40 series of 2020 dated May 27, 2020 approves the recommendations of the IATF sub-Technical Working Group (sTWG) on Data Analytics on the classifications of Provinces, Highly Urbanized Cities (HUCs), and Independent Component Cities (ICCs), the specifics of which are as follows:

*“Beginning 01 June 2020, the risk-level classifications shall be adopted as follows:*

- a. *The following low-risk provinces, HUCs, and ICCs shall be placed under Modified General Community Quarantine (MGCQ) until 15 June 2020, without prejudice to the declaration of localized Enhanced Community Quarantine in critical areas:*

iii. For Mindanao: Region XII – North Cotabato, South Cotabato, Sarangani, Sultan Kudarat, General Santos City and BARMM – Cotabato City

**WHEREAS**, on May 22, 2020, the IATF issued and published amended Omnibus Guidelines on the Implementation of the Community Quarantine in the Philippines. Section 7 of the Guidelines provides for the Interzonal and Intrazonal Movement which reads as follows:

- 1) *“the movement of all types of cargoes by land, air, or sea within and across areas placed under any form of community quarantine shall be unhampered. Workers in the logistics sector, such as cargo, trucking, courier delivery and port operational shall likewise be allowed to transit across areas placed under any form of community quarantine. All LGUs are directed to strictly abide by this national policy. Provided, that only a maximum of five (5) personnel may operate cargo and delivery vehicles by land, with or without load”*
  
- 3) *The Interzonal movement of persons between areas placed under GCQ and MGCQ for any purpose other than leisure shall be permitted;*

**WHEREAS**, on June 3, 2020, the IATF issued Resolution No. 43 approving the revisions and amendments to the Omnibus Guidelines on Implementation of Community Quarantine in the Philippines.

*Item 5 of which is read as follows:*

*“Amendments to paragraphs (4) and (5) of Section [7] Guidelines for Interzonal and Intrazonal Movement to emphasize that there should be **no tourism-related travel between GCQ and areas where no community quarantine is in place**; and that travel for tourism purposes between areas under MGCQ to areas where no community quarantine is in place, while allowed, are still subject to regulations.*

*These shall be read as follows:*

*(5) the movement of persons for any purpose across areas places under MGCQ and areas where no community quarantine is in place shall be permitted...*

**WHEREAS**, per DOH-CHD 12 COVID Tracker on COVID, from the period June 1, 2020 to June 9, 2020, the Region has recorded ten (10) new cases that resulted to a total of 34 COVID-19 cases in the region as of June 9, 2020. The 10 new cases represents 29.41% increase in COVID cases since the Region was put under MGCQ status and

started accepting ROFs and LSIs since June 1, 2020 via land, air and water. The increase was also attributed to the non-disclosure of the ROFs and LSIs, to include those persons transporting essential goods within and outside the region, of their health conditions despite being required by the government before going back to their respective residences;

**WHEREAS**, during the Joint Meeting, the Body discussed the possibility that after June 15, 2020, low-risk provinces, HUCs, and ICCs Quarantine status will be lifted and restrictions will be laxed, notwithstanding the influx of ROFs and LSIs that are coming home to the region, hence, **resurgence of the infection will possibly occur**;


**NOW, THEREFORE**, on motion of RD MACARIO D. GONZAGA of LTO XII and duly seconded by RD TERESITA SOCORRO C. RAMOS of NEDA XII; **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to request IATF to extend Region 12's Regional Border Lockdown until June 30, 2020;

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to National Inter-Agency Task Force on Emerging Infectious Disease (IATF-EID) and National Task Force on COVID-19 for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19, and LCEs of Region 12 for their information and or appropriate action.
