**MEMORANDUM CIRCULAR**

**SUBJECT : PROVINCIAL GOVERNORS, CITY AND MUNICIPAL MAYORS, LIGA NG MGA BARANGAY PROVINCIAL / CITY / MUNICIPAL CHAPTER PRESIDENTS, DILG REGIONAL DIRECTORS OF REGIONS IX, X, XI, XII, CARAGA, ARMM DILG REGIONAL SECRETARY AND ALL OTHERS CONCERNED**

**SUBJECT : ATTENDANCE TO THE LIGA NG MGA BARANGAY SA PILIPINAS – MINDANAO CHAPTER BANGSAMORO BASIC LAW FORUM**

The Liga ng mga Barangay sa Pilipinas (LnB) – Mindanao Chapter (Regions IX, X, XI, XII, CARAGA and ARMM) in partnership with the Office of the Presidential Adviser on the Peace Process, will hold its Bangsamoro Basic Law Forum on April 23, 2018, at the SMX Convention Center, Pasay City, with the theme: “Forum on the Proposed Bangsamoro Basic Law with Liga ng mga Barangay sa Pilipinas: Partners in Promoting Peace in the Bangsamoro”.

The main topics of the activity are as follows: 1) To impart among members of the Liga ng mga Barangay sa Pilipinas the salient features of the proposed BBL that is currently being deliberated in the 17<sup>th</sup> Congress; 2) To deepen understanding of the members of the LnB on the historical context and of the Moro struggle and the Mindanao peace process; and, 3) To discuss the roles of the Local Government Units in the future Bangsamoro as provided for in the proposed BBL.

In this connection, through the request of Hon. Gerard Hilarion M. Ramino, LnB-Vice President for Mindanao, all Regional/Provincial/City/Municipal LnB Presidents, Barangay Officials and Members in Regions IX, X, XI, XII, CARAGA and ARMM, are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee in the amount of PHP13,500 per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability hereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee

shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-Vice President for Mindanao shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said assembly.

All DILG Regional Directors and Field Officers in Regions IX, X, XI, XII, CARAGA and ARMM are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
