## 4<sup>th</sup> INTERNATIONAL CONFERENCE ON CHILDREN AND YOUNG ADULTS' LIBRARIANSHIP

Memorandum Circular No. 2017-72  
June 7, 2017

### 1.0 Background

The National Library of the Philippines (NLP) is mandated to promote life-long learning which aims to lead in the development of children and young adult services in libraries.

This year, NLP in cooperation with the local government unit (LGU) of Naga City through its library, will host the 4<sup>th</sup> International Conference on Children and Young Adult's Librarianship with the theme: "Engage, Enrich, Expand Access Towards the Development of a Reading Culture". The conference will be held on July 19-21, 2017 in Naga City.

### 2.0 Purpose

The purpose of the Circular is to enjoin LGUs to support the said International Conference on Children and Young Adults' Librarianship.

### 3.0 Scope/Coverage

All Provincial Governors, City and Municipal Mayors, DILG Regional Directors, ARMM Regional Governor, and all others concerned

### 4.0 Policy Content and Guidelines

- 4.1 All library personnel are invited to participate in the event. Continuing Professional Development (CPD) units will be applied. A discounted fee of Php 5,500.00 for early birds and live-in participants and Php 4,500.00 for live out participants will be charged until June 15, 2017. A participation fee of Php 6,000.00 for live-in participants and Php 5,000.00 for live-out participants will be charged beyond June 15, 2017.
- 4.2 Participation fee for live-in participants will cover a two-night accommodation, full meals (am/pm snacks, breakfast, lunch and dinner during the conference), kits and certificates. For live-out participants, the fee will cover am/pm snacks, lunch, kits and certificates only.
- 4.3 The fees may be paid in cash or check to:

- 4.2 The payment of applicable travelling expenses, and registration fee, to defray the costs of hotel accommodation, meals and conference materials, per participant, may be authorized chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, that travelling expenses and registration fee of local government participants shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.
