SUBJECT : ADVOCACY ON CHARTER CHANGE: ORIENTATION
CUM TRAINING AND CONSULTATION

In support of efforts to effectively reach out to the general public relative to the need to amend certain provisions of the 1987 Constitution, the Union of Local Authorities of the Philippines, in partnership with the Charter Change Advocacy Commission, is organizing a series of orientation cum training and consultations on Charter Change at the provincial, component city, municipal and barangay levels. Participants

At the provincial level, expected participants are Provincial Elective and Appointive Officials and Component City and Municipal Mayors, as well as their Liga ng mga Barangay Federation Presidents. At the Component City and Municipal Levels, expected participants are members of the Sanggunian, all Punong Barangays and Barangay Secretaries, including civic and religious groups such as the Parish Pastoral Council for Responsible Voting, Knights of Rizal, Born-Again Christians, Kiwanis, Knights of Columbus, Lions, Rotary, Jaycees, Couples for Christ and similar organizations. At the barangay level, expected participants are Barangay Kagawads, Lupon Members, Tanods and residents.

Relative to the above, all Provincial Governors, Component City Mayors, Municipal Mayors and Punong Barangays are hereby encouraged to:

1. Support, participate, and see to it that participants as stated above attend their respective orientation cum training or consultation schedules; and
2. Provide the venues for such orientation cum training and consultations in their jurisdictions.
