SUBJECT

INVENTORY OF CHILDREN IN CONFLICT WITH THE

LAW (CICL)

The enactment of Republic Act 9344, otherwise known as the "Juvenile Justice Welfare Act" mandates the release of CICL, as provided for in Section 64-68 of the said Act.

One of the immediate requirements to facilitate compliance to the law is the inventory of CICL nationwide so that their individual cases be assessed to facilitate their release from detention. The Department, as member of the Juvenile Justice Welfare Council (JJWC) created under said law, has been tasked to assist in the inventory of those CICL in provincial jails and PNP detention cells.

In view thereof, all Provincial Governors and PNP Regional Directors are hereby enjoined to:

A. Provincial Governments

 Through their provincial wardens, accomplish and submit said listing using the attached form and other related information to DILG regional office that covers their province within one (1) week upon receipt of this issuance.

B. PNP Regional Offices

- Direct concerned PNP provincial, city, municipal stations to submit ASAP inventory of CICL using the attached form
- Consolidate and submit the inventory to DILG regional office that covers their jurisdiction.

Deadline for submission is set on 15 June 2006 as required by the JJWC. DILG Regional Offices are hereby directed to coordinate with the provincial governments and PNP regional and field offices to ensure the widest dissemination of this Circular and the immediate submission of documents in compliance to RA 9344.
