In line with the current thrusts of the government to alleviate poverty through livelihood development and employment generation, the Department of Trade and Industry Region 2 and the Department of Science and Technology (DOST) through the Philippine Council for Agriculture, Forestry, Natural Resources Research and Development (PCARRD) in cooperation with various government and private organizations, will conduct the Forum on Barangay Livelihood Initiatives and Entrepreneurial Ventures Part 2, Hog Integrated Export Development Program (B.L.I.V.E. in Hogs) on March 21-23, 2007 at the Hotel Supreme, Magsaysay Avenue, Baguio City.
