**MEMORANDUM CIRCULAR**

**TO :** ALL DILG REGIONAL DIRECTORS, FIELD OFFICERS,  
 HOLD-OVER NATIONAL LIGA FEDERATION OFFICERS  
 AND LOCAL OFFICIALS CONCERNED

**SUBJECT :** ELECTION OF THE LIGA NG MGA BARANGAY  
 NATIONAL FEDERATION OFFICERS

As per DILG Memorandum Circular No. 2007-151 dated 19 November 2007, between 5-17 January 2008, the incumbent National Liga President or in his absence, the next highest ranking incumbent official, should have already sent written notices to the duly elected Provincial/Metropolitan/Highly Urbanized City (HUC)/Independent Component City (ICC) Liga Chapter Presidents as well as the incumbent National Liga Board, for the purpose of forming the various committees and boards on 18 January 2008 for the upcoming 29 January 2008 election of National Liga Federation Officers.

The written notice shall include the following:

- 1) 18 January 2008 meeting for the formation of the various committees for the purpose of the 29 January 2008 National Liga election indicating the time and place of the meeting;
- 2) 29 January 2008 election meeting together with the time and place of the said meeting and the requirements of the National Liga election.

For the purpose of the abovementioned Formation Meeting of the various committees and the Election Meeting of the Liga ng mga Barangay


National Federation Officers, only those duly elected Liga presidents of the Provincial/Metropolitan/Highly Urbanized and Independent City Chapter, as evidenced by their Certificate of Canvass and Proclamation certified to and attested by the Board of Election Supervisors (BES), supervised by the DILG, and confirmed to this effect by the National Liga Board, shall be entitled to participate, vote and be voted upon on the 18<sup>th</sup> and 29<sup>th</sup> January 2008 meetings.

In cases where the National Liga issues Certificate of Confirmation to "Liga President" different from the winning candidate as proclaimed in the Certificate of Canvass and Proclamation duly certified to and attested by the BES in a DILG supervised election, it is the latter who shall be entitled to participate, vote and be voted upon in the aforesaid meetings provided that he/she complies with the other requirements set forth under the pertinent DILG Memorandum Circulars and the Liga Election Code of 2002.

To ensure the widest participation in the election of the National Liga officers, the Regional Directors are hereby directed to disseminate the Notice issued by the hold-over National Liga President, Hon. James Marty Lim, a copy of which is hereto attached, to the Liga Presidents proclaimed under the duly issued Certificate of Canvass and Proclamation by the BES.
