**MEMORANDUM CIRCULAR**

**TO :** ALL HIGHLY URBANIZED CITY (HUC)/ INDEPENDENT COMPONENT CITY (ICC) MAYORS, LIGA NG MGA BARANGAY (LnB) HUC/ICC CHAPTER PRESIDENTS, VICE PRESIDENTS, AUDITORS AND BOARD MEMBERS, DILG REGIONAL DIRECTORS/FIELD OFFICERS AND OTHERS CONCERNED

**SUBJECT :** PARTICIPATION OF OTHER LnB CHAPTER OFFICERS FROM THE HUCs/ICCs IN THE 1<sup>st</sup> LIGA NG MGA BARANGAY NATIONAL CONVENTION

Relative to the above subject activity which will be held on **March 13-15, 2008 at Clamshell, Intramuros, Manila** and upon the request of National LnB, all HUC/ICC Mayors are hereby encouraged to allow their LnB Chapter Vice Presidents, Auditors and Board Members to participate in the said National Convention on official business.

Payment of applicable traveling expenses as well as reasonable registration fee of the participants to cover hotel accommodation; food and snacks on March 14 until breakfast of March 15; inter-hotel transportation; and convention kit is hereby authorized, chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing rules and regulations, provided that the 20% Development Fund shall not be utilized for the purpose.

The **Registration Fee** for delegates who will opt to be **billeted (Twin Sharing)** is **Ten Thousand Pesos (PhP 10,000.00)**, while for **live-out participants**, it is **Five Thousand Pesos (PhP 5,000.00)**.

The delegates will be billeted at the Manila Pavillion, Manila Hotel, Bayview Hotel and Heritage Hotel (please see attached). Registration will be on **March 13, 2008** starting at **1:00P.M. and onwards** at the **Hotels of their**


**respective regional assignments. The attire will be Barong Tagalog for men, while for the ladies, as appropriate.**
