SYNCHRONIZED BARANGAY ASSEMBLY DAY FOR THE FIRST

SEMESTER OF CY 2008

Pursuant to Proclamation No. 342 "Declaring the Last Saturday of March 2003 and the Third Saturday of October 2003 and Every Year Thereafter as Barangay Assembly Day", the Synchronized Barangay Assembly Day for the first semester of CY 2008 will be on March 29, 2008. Relative thereto the following are the suggested/recommended activities to be undertaken:

- a. Presentation of Accomplishment and Financial Reports from July to December 2007; and
- b. Discussion on problems, issues and concerns affecting the barangays
- c. Report on the organization of the following, but not limited to:
 - Sangguniang Barangay various committees
 - Barangay Development Council
 - Barangay Peace and Order Committee
 - Barangay Disaster and Coordinating Council
 - Lupong Tagapamayapa (Lupon)
 - Barangay Tanods

In addition, those barangays that have not elected their Barangay Human Rights Action Officers (BHRAOs) are hereby advised to conduct the election on the said day, pursuant to DILG MC No. 2006-45 dated May 11, 2006.

Likewise, the barangay officials may undertake other activities they deem appropriate to encourage more participants to the barangay assembly day.

All Provincial Governors. City and Municipal Mayors are hereby enjoined to extend assistance to the barangays to ensure the successful conduct of the said event.

All Regional Directors and DILG Field Officers are directed to cause the immediate dissemination and provide technical assistance relative to this issuance. Also, you are directed to submit the initial statistical report within a week after the conduct of the said activity, the final report and the List of Barangays with Newly Elected BHRAO's on or before April 30, 2008 to the National Barangay Operations Office (NBOO) thru e-mail at mbreyes@dilg.gov.ph. Also, submit a report containing highlights of activity, major issues and concerns, and recommendations.
