LEGISLATORS LEAGUE OF THE PHILIPPINES (FOUR - L PHIL.)

The Lady Local Legislators League of the Philippines (Four-L, Phil.) will hold their 1st Mindanao Area Conference on May 15-17, 2008 at the Dakak Hotel and Beach Resort, Dapitan City, with the theme: Pursuing Excellence in Local Legislation.

As represented, the conference aims to provide the participants with a venue to refresh their basic knowledge on law making, parliamentary procedure, and budget proposal-making.

In this connection, all concerned Local Chief Executives are encouraged to allow the Lady Members of their Sangguniang Panlalawigan, Sangguniang Panlungsod and Sangguniang Bayan, Lady Liga ng mga Barangay and SK Federation Presidents, National and Chapter Officers and other invited members of the League, to attend the above-mentioned conference, on official business. The payment of traveling expenses and a registration fee of Six Thousand Pesos (Php 6,000.00) for those who register on-site and Five Thousand Five Hundred (Php 5,500.00) for those who pre-register before May 1, 2008, to defray the costs of hotel accommodation, meals and conference materials, per participant, may be authorized, chargeable against local funds, subject to the availability of thereof, to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, that, the traveling expenses and registration fees of participants shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice

The Four-L Philippines National President shall submit to, through the Director of the Bureau of Local Government Supervision, this Department, the Secretary of Interior and Local Government, an After-Activity Report within fifteen (15) days after the end of the said activity,
