SUBJECT : AMENDING MEMORANDUM CIRCULAR NO. 2008-123
DATED AUGUST 20, 2008

Memorandum Circular No. 2008-123 dated August 20, 2008 is hereby amended to include the National Movement of Young Legislators (NMYL) as one of the institutional partners in Mobilizing Local Actions to Address the Impacts of Climate Change.

As indicated in the Memorandum of Understanding, the parties agreed to undertake the project in four phases: Phase 1 – Awareness Building; Phase 2 – Legislative and Executive Actions; Phase 3 - Assessment of Actions; and Phase 4 – Sustaining Strategies. The conduct of the regional conferences is part of Phase 1. This phase aims to create awareness on the consequences of global warming and to generate commitments from local authorities to pursue measures to address. Towards this end, the regional conferences shall highlight the following:

- Impacts of Climate Change on People, Business and the Ecosystems
- Responses to Address Climate Change: Energy Solutions, Vehicle Solutions, Forestry Solutions and Agricultural Solutions; and
- Templates of Legislative and Executive Actions at the Provincial, City and Municipal Levels.



Regional conference convenors and coverage shall be as follows:

Convenor	Regional Coverage
4-L	Regions I, V and IX
NMYL	Region II
PBMLP	Regions III, VIII and XI
PCL	Regions IV-B, XII and NCR
VMLP	Regions IV-A, VI, X and CARAGA
LLPDCPI	Regions VII, CAR and ARMM

The regional conferences shall be implemented within the period, November, 2008 to September, 2009. Other details such as conference dates and venues, as well as the sending of the invitations to concerned local authorities shall be provided by the convenor-league.

In this connection, Provincial Governors, Vice-Governors, City and Municipal Mayors, City and Municipal Vice-Mayors, Members of the Sanggunians, Punong Barangays and Provincial, City and Municipal Planning and Developments Coordinators are hereby enjoined to attend the said regional conferences.

All DILG Regional Directors are hereby directed to cause the widest dissemination of this issuance to all local authorities within their jurisdictions.
