To promote the ideals and teachings of our national hero, Dr. Jose P. Rizal and in line with its statutory mandate under RA No. 646, the Order of the Knights of Rizal (OKOR), through the Kabataang Pangarap ni Rizal (KAPARIZ) with the Youth Leadership Excellence for Active Development Philippines (Youth LEAD Philippines) shall be conducting the first ever "BIDA (Building Initiatives for Desire and Action) Ka! National Young Leaders Summit (BNYLS)", carrying the theme, "The Filipino Youth: Harnessing the Power of Greatness". The activity aims to:

In view of the above, and upon request of Mr. Metodio B. Maraguinot, Jr., National President of the Kabataang Pangarap ni Rizal National Council, all Local Chief Executives (LCEs) are hereby encouraged to allow the participation of their SK Officials to the abovementioned activity to be held on **October 28-30**, **2011 at Bohol Plaza Resort**, **Panglao Island**, **Bohol**.

Likewise, they may encourage the attendance of other **Youth Leaders** in their respective jurisdictions.

The payment of applicable travel expenses and registration fee of **Php 5,800.00** to defray the cost of hotel accommodation, meals and conference materials, may be authorized chargeable against local funds, subject to availability thereof, and to all pertinent laws, rules and regulations. Provided, that the travelling expenses and registration fees of participants shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.
