SUBJECT : 50th NATIONAL RIZAL YOUTH LEADERSHIP INSTITUTE (NRYLI) CONFERENCE

Year 2012 is a milestone to the Order of the Knights of Rizal (OKOR) as it commemorates the Golden Year of gathering the youth of the land by sponsoring the National Rizal Youth Leadership Institute Conference (NRYLI Conference) on 13-16 December 2012 in Teacher's Camp, Baguio City, with the Theme: "Buhayin si Rizal sa Bawa't Kabataang Pilipino".

In view of the above, and upon the request of Sir Jeremias C. The payment of registration fee in the amount of **Six Thousand Five Hundred (Php 6,500) Pesos** per participant to defray the costs of venue, meals and snacks and materials, and applicable travel expenses may be authorized chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations.

The OKOR shall submit a post-activity report to the DILG Secretary, through the National Barangay Operations Office (NBOO), within a month after the conduct of the said activity, with the following prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Outputs of Technical Sessions;
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees collected and Disbursed; and
- VI. Appendices, if any.
