SUBJECT : UNESCO CLUB WORLD HERITAGE EDUCATION AND ENCOUNTER

The National Association of UNESCO Clubs in the Philippines (NAUCP), Inc., in partnership with UNESCO National Commission of the Philippines will spearhead the UNESCO Club World Heritage Education and Encounter, a seminar-workshop series in Ifugao on October 11-13, 2012, in Ilocos on October 18-20, 2012 and in Palawan on October 25-27, 2012 with the Theme: "Youth, Social Media and Natural and Cultural Heritage Preservation".

In view of the above, and upon the request of Prof. Serafin A. Arviola, Jr., NAUCP Chairman, all Local Chief Executives are hereby encouraged to allow the participation of their SK youth leaders and young local legislators ages 35 years old and below to the abovementioned activity, on official time.

The payment of registration fee in the amount of **Eight Thousand Five Hundred (Php 8,500) Pesos** per workshop series per participant to defray the costs of venue, meals and snacks and materials, and applicable travel expenses may be authorized chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations.



- VI. Appendices, if any.
