

4<sup>TH</sup> MANILA CONFERENCE FOR THE PREVENTION OF CHILD

ABUSE AND NEGLECT: "AKO PARA SA BATA 2012 (I AM FOR

THE CHILD)"

The Child Protection Network Foundation Inc. (CPN), is an NGO partner of various National Government Agencies which provides trainings to physicians, social workers, nurses and other organizations involved in the Women and Children Protection Unit (WCPU).

CPN is organizing the 4<sup>th</sup> Manila Conference for the Prevention of Child Abuse and Neglect on December 5-7, 2012 at the SMX Convention Center, Pasay City, with the theme: "Battling BAD Behaviors: Enabling Adults to Respond Positively and Effectively to Children" which will focus on understanding and assessing behavioral problems and guidelines to prevent escalation of the behavior and will discuss general principles of interventions for more difficult cases.

In view thereof, all Local Chief Executives are hereby encouraged to send their social workers, health workers, women and children's Protection Desk Officers and others who would be in the best position to apply new knowledge.

Registration fee of Three Thousand Six Hundred Pesos (P3,600.00) per participant may be authorized, subject to the availability of funds and to the usual accounting and auditing rules and regulations. The participants may avail of the discounted rate of P3,000.00, provided they register and pay the fee on or before November 5, 2012.

Registration fee includes the following:

- Two-day delegate pass to all plenary sessions
- Two-day delegate pass to any symposia
- Conference Kit
- Meals for two days (lunch, AM & PM snacks)
- Certificate of attendance
- Complimentary pass to the fellowship night on December 6, 2012
