SUBJECT

18-DAY CAMPAIGN TO END VIOLENCE AGAINST WOMEN

The 2012 observance of the 18-Day Campaign to End Violence Against Women (VAW) starts on November 25 and ends on December 12.

With the theme, "VAW – Free Society in Times of Peace, Conflict and Calamity", this year's campaign will focus on gender-based violence during disasters and armed conflict situations. This is in line with the international theme anchored on the intersections of gender-based violence and militarism, and with the recent onslaught of calamities which affected many women and children which made them more vulnerable to gender-based violence.

In this regard, LGUs are hereby enjoined to commemorate the 18-Day Campaign to End VAW in their respective localities with the following activities:

- Participate in the Kick-Off Activity "Light to Fight: A Call to End VAW" on November 25 (Sunday) at 3:00 P.M. (Assembly Time) at the Quirino Grandstand, Manila (for NCR and nearby areas);
- Bring delegation of at least twenty (20) persons in the Kick-Off Activity (for NCR and nearby areas) wearing the 18-Day Campaign 2012 advocacy shirt (visit PCW website for the t-shirt design);
- Bring sky lanterns (visit PCW website for the sky lantern design and supplier)
  which shall be lighted and released simultaneously during the Kick-Off Activity;
- Non-NCR LGUs to initiate a Kick-Off Activity simultaneous with the one to be held in Manila;



- Hang a streamer in front of the municipality/city/provincial hall announcing the LGUs participation in the campaign (see PCW website for specifications/design of the streamer);
- Conduct agency specific activities towards ending VAW and to submit by December 15, 2012 a report of activities conducted to Philippine Commission on Women (PCW);
- LGUs to visit the PCW website (Philippine GAD Portal) at <a href="www.pcw.gov.ph">www.pcw.gov.ph</a> to encode in the Campaign Calendar the activities to be conducted following the template provided therewith and for more details on the 18-Day Campaign; and
- Visit <a href="www.iacat.net">www.iacat.net</a> for details on the commemoration of the International Day Against Trafficking (IDAT).
