SUBJECT

GOVERNOR'S GENDER AND DEVELOPMENT (GAD) SUMMIT

In view of the recently signed PCW-DILG-DBM-NEDA Joint Memorandum Circular (JMC) 2013-01 or the Guidelines on the Localization of the Magna Carta of Women (MCW), the Governor's GAD Summit with the theme "Seal of Transformational Leadership Towards Gender Responsive Local Governance" will be jointly organized and conducted by the Philippine Commission on Women (PCW) and the Department of the Interior and Local Government (DILG) together with the Department of Budget and Management (DBM), the National Economic Development Authority (NEDA), Commission on Audit (COA) and the Leagues of Provinces of the Philippines (LPP).

The Summit aims to bring together the eighty (80) Provincial Governors in the country to support gender dialogues for women empowerment and gender equality as well as sharing of GAD good practices. Further, integrated and concerted actions among Local Chief Executives (LCEs) are essential, especially among the newly elected Governors, to ensure systematic and institutional support in pursuing gender-responsive governance.

In this regard, all Provincial Governors are hereby enjoined to participate in the Governor's GAD Summit on November 21, 2013 at Diamond Hotel, Dr. J. Quintos, cor. Roxas, Blvd., Malate Manila. The Philippine Commission on Women (PCW) will cover the cost of overnight accommodation, meals and kits on the day of the Summit. Transportation and other incidental expenses is hereby authorized charged to their respective GAD Budget subject to the usual accounting and auditing rules and regulations.
