SUBJECT : ENCOURAGING LOCAL GOVERNMENT UNITS TO ATTEND THE 6<sup>th</sup> SUMMIT AND THE 3<sup>rd</sup> eGOV AWARDS NIGHT, OCTOBER 24, 2014 IN DAVAO CITY

The National ICT Confederation of the Philippines (NICP) will conduct the 6<sup>th</sup> SummIT and the 3<sup>rd</sup> eGov Awards Night on October 24, 2014 at SMX Premier, Lanang, Davao City.

The event aims to develop the Information Communication Technology (ICT) ecosystem of the local government units through the sharing of best practices on eGovernance. There will also be a BIMP-EAGA Trade Fair week, welcoming delegates from the East ASEAN countries like Brunei, Indonesia, Malaysia and Thailand. The plenary session will focused on relevant topics to include a review of the ASEAN 2015 ICT Master Plan, ASEAN Global Sourcing Opportunities, Digital Tourism for Agribusinesses and eGovernance.

In addition to the summit, NICP will also give awards to the Local Government Units (LGUs) who shows an excellent performance on harnessing ICT in delivering basic services to their constituents. The award is divided into to two (2) major categories namely Best in eGov Customer Empowerment (G2C) Award and Best in eGov Business Empowerment (G2B).

In this connection and upon the request of Ms. Lizabel G.Holganza, NICP President, all local government units are encouraged to participate on the above mentioned activity on official business subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided that the travelling expenses shall not be charged against the twenty (20%) percent component of the Internal Revenue Allotment (IRA) or from whatever source that ay prejudice on-going poverty alleviation efforts.
