The Inter-Agency Committee (IAC) on the Celebration of the Month of Overseas Filipinos (MOF) and International Migrants Day, chaired by the Philippine Migrants Rights Watch (PMRW), and co-chaired by the Commission on Filipinos Overseas (CFO) is spearheading the Celebration of the Month of Overseas Filipinos in December, 2014.

Relative thereto and pursuant to Presidential Proclamation No. 276 dated June 21, 1998, declaring December of every year as "Month of Overseas Filipinos", and United Nations' General Assembly Resolution, proclaiming December 18 of every year as "International Migrants Day", all Local Chief Executives are encouraged to:

- σ Organize MOF activities, such as, but not limited to, forum on migration, Balikbayan Night, sportsfest, fun run, film showing on migration, art exhibit, and other activities that may be of interest or relevance to migrants and their families in recognition of their role in nation building and local development;

- σ Provide funding or seek grants and donations from other entities in financing MOF activities.
