SYSTEM (CBMS)-PHILIPPINES NATIONAL CONFERENCE

The CBMS International Network Coordinating Team of the De La Salle University (DLSU)-Angelo King Institute for Economic and Business Studies in partnership with the Department of the Interior and Local Government (DILG) will hold the 11th CBMS-Philippines National Conference on February 2-4, 2015, 8:00AM - 5:00PM at the Crowne Plaza Manila Galleria, Ortigas Avenue, Corner ADB Avenue, Quezon City. The use of CBMS as a tool for local planning and budgeting is being promoted by the DILG in collaboration with the CBMS International Network Coordinating Team since 2005. As of October 8, 2014, CBMS has been adopted by LGUs in 73 provinces, (32 of which are province-wide), covering 862 municipalities, 69 cities and 23, 276 barangays.

The 3-day conference shall convene national and local planners, policymakers program implementers and various stakeholders in the country to discuss current developments and best practices on the implementation and use of the Community-Based Monitoring System. It shall feature presentations and discussions on the uses of CBMS for Grassroots Participatory Budgeting Process (GPBP), localizing the Millennium Development Goals (MDGs), Disaster Risk Reduction Management (DRRM) and Climate Change Adaptation (CCA), local poverty reduction action planning, local programming and project prioritization, impact-monitoring, and improving local governance. This year's conference will feature best practices on the implementation and uses of CBMS for fostering transparency and accountability in local governance, and sustaining development initiatives.

The annual CBMS national conference provides a venue for establishing and fostering partnerships among national government agencies, local government units, academe and research communities, non-government organizations, civil society, and other development partners on the use of CBMS outputs towards scaling up poverty reduction efforts and other related development initiatives nationwide.

In view of this, all Local Chief Executives (LCEs) and other local officials, DILG Regional/Provincial/City Directors, Municipal Local Government Operations Officers and CBMS focal persons are hereby encouraged to attend the said conference. Travelling expenses and applicable conference registration fee per participant is hereby allowed chargeable against their respective local funds, subject to the availability of funds, and to the usual accounting and auditing rules and regulations.
