SUBJECT : SEARCH FOR THE EXEMPLARY GOVERNMENT REGISTERED SOCIAL
WORKERS AWARDS (DURING TYPHOON YOLANDA (HAIYAN) DISASTER
OPERATIONS)

The Council for the Welfare of Children (CWC), in partnership with the Consuelo Foundation, is putting forward a project of recognizing and giving awards to government social workers that have been in the forefront of the devastation brought about by Typhoon Yolanda (Haiyan). This Award will recognize exemplary social workers with ingenuity, and innovation in a disaster and crisis situation in the discharge of their functions in providing services for children and families affected by extreme weather events brought about by Typhoon Yolanda.

The search is open to government registered social workers who have demonstrated groundbreaking and commendable practices working in Regions IV-B (MIMAROPA), V, VI, VII, VIII, and NCR, and directly involved during the Typhoon Yolanda (Haiyan) disaster operations.

For the grand prize, the winner will receive PhP100,000.00, and four (4) special awards shall receive a cash prize of PhP75,000.00 each. Nominees must be able to show evidence of creativity, innovativeness and valuable use of available resources which had positive impact to the physical and psychosocial circumstances of the typhoon victims. Nominations can be submitted by a third party to include their contact details, from any of the following:

- Direct supervisor or co-worker of the nominee;
- Chairperson or the members of the six (6) Regional Sub-committee on the Welfare of Children (CWC);
- Chairperson or the members of their respective Local Councils for the Protection of Children (P/C/M/B/CPC);
- Local Stakeholders (NGOs, Faith Based Organizations, (FBOs), media and community organizations (civic groups, peoples organizations); and
- Professional associations

Closing date on the submission of entries is on February 2, 2015.
