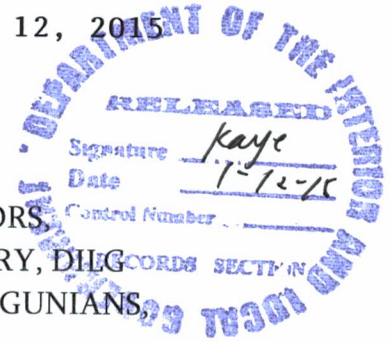

SUBJECT : THE 21<sup>st</sup> NATIONAL CONGRESS OF THE NATIONAL  
MOVEMENT OF YOUNG LEGISLATORS



The National Movement of Young Legislators (NMYL) will be conducting its 21<sup>st</sup> National Congress on February 26-28, 2015 at Henann Garden Resort, Boracay, Malay, Aklan aiming to strengthen the members' idealism and commitment to good governance in the performance of their tasks in local government, particularly in the field of legislation and policy development.

This year's National Congress shall serve as a venue to discuss the following agenda:

1. SK Reform and Youth Legislation;
2. Advancing the Cause of Performance, Accountability and Participation – Climate Change Adaptation and Disaster Preparedness Guidelines; and
3. Deliberation and Ratification on the Proposed Amendments of the Constitution and By-Laws of the League
