



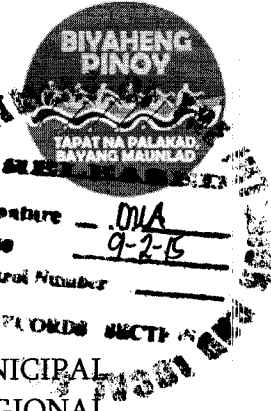

SUBJECT : 2015 URBAN ENVIRONMENTAL ACCORDS SUMMIT FROM SEPTEMBER 15-17, 2015 IN ILOILO CITY

To achieve urban sustainability, promote healthy economies, advance social equity, and protect the world's ecosystems, the United Nations Urban Environmental Accords came up with a series of action-oriented goals that can be adopted at the city levels, reflecting sustainable measures that support sustainable utilization and management of energy, urban design, waste reduction, urban nature, transportation, environmental health and water resources and improvements in the general health and economic well-being of cities.

Iloilo City will proudly host the 2015 Urban Environmental Accords (UEA) Summit, with the theme, "Green City, Livable City," to be held from September 15 to 17, 2015 at Sarabia Manor Hotel and Convention Center, Iloilo City. More than 500 mayors and city representatives from UEA member cities, local and international organizations, and non-government organizations are expected to join in this event. The Summit will feature global presentations, dialogue and open forum, exhibits and thematic tours that will witness a vibrant exchange of knowledge and information in advancing the Earth Summit Agenda 21.
