SUBJECT : ATTENDANCE TO THE 2015 NATIONAL ASSEMBLY OF THE LIGA
NG MGA BARANGAY SA PILIPINAS (LnB)

The Liga ng mga Barangay sa Pilipinas (LnB) will hold its 2015 National Assembly on September 28-30, 2015 at the Marriott Grand Ballroom, Marriott Hotel, Pasay City.

The highlight of the activity will be the Awarding Ceremony for the Lupong Tagapamayapa Incentives Awards (LTIA) to be graced by His Excellency President Benigno Simeon Aquino III. The activity also aims to orient the participants on Ugnayan ng Barangay at Simbahan (UBAS), Disaster Risk Management, Barangay Peace Keeping Action Team (BPAT), DILG Programs and Projects for Barangays with emphasis on BUB, Benefits and Privileges of LnB members and other organizational concerns.


In this connection, through the request of Hon. Edmund R. Abesamis, LnB-National President, all Regional/Provincial/City/Municipal LnB Chapter Presidents, Barangay Officials and Members, are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-National President shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said assembly.

All DILG Regional Directors and Field Officers are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
