ATTENDANCE TO THE 12TH MINDANAO ISLAND CONFERENCE

OF THE PROVINCIAL BOARD MEMBERS LEAGUE OF THE

PHILIPPINES (PBMLP)

The Provincial Board Members League of the Philippines (PBMLP) will hold their 12TH Mindanao Island Conference on *September 16 -18, 2015 at Luxe Hotel, Limketkai Center, Cagayan de Oro City*, with the theme "Enhancing Good Governance: Revisiting the Positive Gains of Moral Re-Orientation".

The objective of the conference is to provide an avenue for thematic discussions on: 1) Understanding Political Accountability and Campaign Financing; and 2) Leveraging Good Governance and Moral Fiber through National Political Exercise.

In this connection, and upon the request of Hon. Myrna M. Romarate, National President, PBMLP, all concerned Provincial Board Members are hereby encouraged to participate in the said activity on official business.

Consistent with Article XIII, Section 3 of the PBMLP's Constitution and By-Laws (CBL) providing for the conduct of island conferences and special meetings, and Article XV, Section 01 of said CBL which provides for the sources of funds of the said league, the payment of conference fee to defray the cost of hotel accommodation, meals and conference kit, as well as travelling expenses, may be authorized, chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements, and to all pertinent laws, rules and regulations.

The PBMLP National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of Interior and Local Government, a Post Activity Report within fifteen (15) days after the conduct of the said conference, with the following format:

- I. Executive Brief;
- II. List of Participants;
- III. Outputs of the Technical Sessions;
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees and Disbursements; and
- VI. Appendices, if any.

DILG Regional Directors, through their respective Field Officers, are directed to cause the dissemination of this Circular.
