ATTENDANCE TO THE 2015 LUZON ISLAND CONGRESS OF THE

LIGA NG MGA BARANGAY SA PILIPINAS (LnB)

The Liga ng mga Barangay sa Pilipinas (LnB) – Luzon Chapter (Regions I, II, III, IV-A, IV-B, V, CAR and NCR) will hold its 1<sup>st</sup> Luzon Congress on November 20-23, 2015 at the Crown Regency Resorts and Convention Center, Boracay Island, Malay, Aklan, with the theme "Barangay: Pangkapaligirang Proteksyon at Pagbabago ng Klima ay Kritikal para sa Kinabukasan ng ating mga Kabarangay at Kapamilya."

In this connection, through the request of Hon. Vicente G. Pagurayan, LnB Vice President for Luzon Chapter, all Regional/Provincial/City/Municipal LnB Chapter Presidents, Barangay Officials and Members in Regions I, II, III, IV-A, IV-B, V, CAR and NCR are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB- President for Luzon shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said assembly.

All DILG Regional Directors and Field Officers in Regions I, II, III, IV-A, IV-B, V, CAR and NCR are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
