MEMORANDUM CIRCULAR

TO : ALL PROVINCIAL GOVERNORS, MUNICIPAL MAYORS, DILG REGIONAL DIRECTORS, DILG ARMM REGIONAL SECRETARY, AND OTHERS CONCERNED

SUBJECT : 2015 ISLAND CLUSTER CONFERENCES OF THE LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES



Pursuant to Section 9, Article VI of the Constitution and By-Laws of the League of Municipalities of the Philippines (LMP), the League will be conducting its 2015 Island Cluster Conferences on the following schedules:

Luzon Cluster	July 22-24, 2015	Vigan City	"Tuloy-tuloy, Sama-sama"
Visayas Cluster	September 2-4, 2015	Iloilo City	"One Team, One Direction"
Mindanao Cluster	August 12-14, 2015	Davao City	"United in Diversity, Strength in Unity"

The themes of the island conferences focus on uniting national and local government leaders toward a common purpose of reducing poverty and achieving inclusive growth. The conferences will also provide a venue for setting directions and goals for the next term.

In view of the above, and upon the request of Mayor Abraham "Jess" T. Burahan, Secretary General of LMP, all Provincial Governors are encouraged to allow their Municipal Mayors to attend their respective island conferences on official business.

The payment of applicable travelling expenses and participation fee, if any, to defray the costs of hotel accommodation, meals and conference materials, per participant, may be authorized chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations.

The LMP National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of Interior and Local Government, a Post-activity Report within fifteen (15) days after the said activity has been conducted, with the following prescribed format:

- III. Output of Technical Sessions
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees Collected and Disbursed; and,
- VI. Appendices, if any.

All DILG Regional Directors are hereby directed to cause the widest dissemination of this issuance to the concerned authorities within their jurisdictions.
