Proclamation No. 361 (2000), as amended by Administrative Order No. 35 (2002) states that the National Disability and Prevention (NDPR) Week shall be observed by the entire country from July 17 to 23 of each year under the auspices of the National Council on Disability Affairs (NCDA). It is also stated that it is the national interest to stimulate public awareness on all matters and issues involving persons with disabilities and encourage every citizen to take active responsibility in uplifting their economic and social conditions as well as recognizing the abilities of our brethren with disabilities.

This year, the country will be celebrating the 37th year of the NDPR week with the theme "Health and Wellness Opportunities for Persons with Disabilities Toward an Inclusive Development for All" which aims to promote the quality health care services for persons with disabilities (PWDs) such as disability prevention, medical treatment and rehabilitation, among others.

In line with the celebration, we enjoin all the local government to support the observance of the above-mentioned celebration, by conducting fitting activities such as but not limited to the following:

- Coping Skills of Parents of Children with Disabilities
- Developmental Games for Children with Disabilities e.g. Boccia Tournament
- Forum on Health and Wellness for Parents of Children with Disabilities
- Seminar on Benefits and Privileges for PWDs
- Seminar/Training on Disaster Risk Reduction Management
- Orientation on the Prevention of Drug Addiction

- Livelihood fair
