Memorandum Circular No. 2015-81

TO: DILG REGIONAL DIRECTORS, DILG PROVINCIAL DIRECTORS, DILG CITY DIRECTORS, AND MLGOOs; PROVINCIAL GOVERNORS, CITY MAYORS AND MUNICIPAL MAYORS OF YOLANDA-AFFECTED LGUs IN REGION IV-B, V, VI, VII, VIII; AND OTHERS CONCERNED

SUBJECT AMENDMENT TO DILG MC 47-SERIES OF 2014: GUIDELINES FOR THE MANAGEMENT OF THE RAY-DILG FUND BATCH 2 – BARANGAY FACILITIES

2. AMENDMENT TO THE IMPLEMENTATION ARRANGEMENT

Section 4.3.1 of Memorandum Circular No. 47 Series 2014 issued on November 27, 2014 **is hereby amended to read as follows:**

The City/Municipality (interchangeably referred as the LGU) shall be responsible and accountable for the implementation of barangay facilities either **by administration or by contract**, which shall be consistent with the Program of Works (POWs) to be reviewed by the DILG Region/Province. The LGU if they may opt to implement by Administration shall secure the DPWH Certification.


Prior to the release of the funds to a particular affected LGU, the Regional Director and the LCE of the LGU shall sign a Memorandum of Agreement (MOA). The Barangay Captains of the said LGU (whose Barangays are beneficiaries of RAY-DILG Fund Batch 2) will serve as witness to the MOA and shall affix their signature thereto. The POW submitted to the Regional Office, duly approved by the Municipal Engineer and the LCE, and

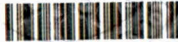
shall form part of the MOA. Before the MOA is signed, the MLGOO shall validate said facility as to its current physical status and cost requirement with corresponding pictures and submit the same to the Regional Office, which will serve as the basis in the amount of funds to be transferred to the LGUs as reflected in the MOA.

For approved Barangay Facilities costing P5,000,000.00 and above, the DILG Regional Office, through the PDMU and the MLGOO shall validate said facility as to its current physical status and cost requirement and shall prepare the revised/updated POW (if necessary) before the signing of the MOA. The POW shall reflect the result of the validation which will be part of the MOA.

3. EFFECTIVITY

This Amendment to Memorandum Circular No. 47-2015 shall take effect immediately.
