COMPETITIVENESS

One of the program areas by the Department of the Interior and Local Government (DILG) is the Business-Friendly and Competitive LGUs which aims to help LGUs in achieving the national agenda towards inclusive growth. Business-friendliness and competitiveness is a condition where LGUs spur sustainable economic and inclusive growth by engaging the business sector, promoting local/trade business and generating employment. A business-friendly and competitive environment can be easily attained when LGUs combined innovation and transparency on their operations using the recent development on Information and Communication Technology (ICT).

In line with the above, the DILG and in partnership with the Department of Trade and Industry (DTI) and Department of Science and Technology-Information and Communications Technology Office (DOST-ICTO) and in collaboration with the Union of Local Authorities of the Philippines (ULAP) and National ICT Confederation of the Philippines (NICP) with the support of Microsoft Philippines, United States Agency for International Development (USAID), Ayala Foundation, Inc. and other private sector partners will conduct an Island-wide ICT Innovations Forum with the theme "Strengthening LGU Capacities Through ICT: Innovation. Competitiveness. Transparency."

The ICT Forum aims to promote the importance and relevance of Information and Communication Technology (ICT) in attaining a business-friendly and competitive environment. ICT in LGUs could bring innovation, enhance living standards, promote growth and shared prosperity. Further, ICT may bring changes on the structure, system and operations of the LGUs in addressing the demand and delivering the needs of their constituents and strengthen LGUs practices on transparency and accountability through prompt delivery of basic services especially in making and doing business.

It will also help the local government units to choose from an array of products that fits to their needs, meet customer demands, reduce costs and address public concerns for a better performance and service delivery. Further, it will also showcase different ICT innovations and practices by LGUs such as on e-BPLS, e-Payment, Text2Teach and others.

The ICT Forum will be conducted in three (3) main islands of the country on the following dates and venue:

The Organizer will provide materials, meals (breakfast, 2 snacks and 1 lunch) during the event and one night accommodation (a night before the forum). Travelling expenses and other incidental expenses related to the event shall be shouldered by the LGUs chargeable against local funds subject to the availability thereof and usual accounting and auditing rules and regulations and other pertinent laws.
