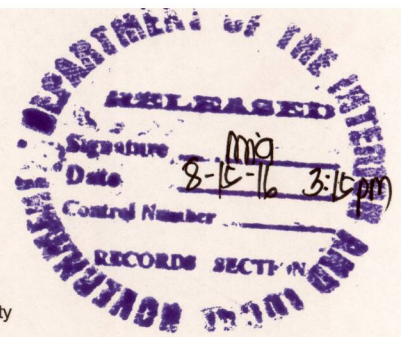

SUBJECT : PRESENTATION OF 2015 CHILD-FRIENDLY LOCAL GOVERNANCE  
AUDIT (CFLGA) RESULTS

Pursuant to DILG Memorandum Circular No. 2014-80, the mandatory Child-Friendly Local Governance Audit (CFLGA) which is conducted annually and covers all Cities and Municipalities nationwide is designed to enhance the delivery of social services for children as the government aimed for Child-Friendly Philippines.

Acknowledging the vital role of Local Chief Executives (LCEs) as chair of the Local Council for the Protection of Children (LCPC) in charting the development of LGUs during the first 100 days in office, an **Exit Conference** for the 2015 CFLGA results must be conducted to discuss the findings of the audit and identify the areas needing immediate attention.


The conference is an opportunity for the LCPCs to discuss ways to allocate funds for children consistent with the recent pronouncement of President Rodrigo Roa Duterte during the 1<sup>st</sup> Cabinet meeting on the role of *all barangay officials as the custodian of children's rights within their jurisdiction*.

In this regard, all CFLGA Audit Teams are hereby enjoined to assist the LCEs in presenting the CFLGA results during the LCPC meeting.

Attached is a template with the national averages for each of the CFLGA indicator as guide. The set of indicators is presented to gauge the performance of the LGU in relation to the national, regional, and provincial average score.

In this regard, all DILG Regional Directors and Field Officers are hereby directed to provide technical assistance and cause the widest dissemination of this Issuance.
