



**PSC-PAQUIAO AMATEUR BOXING CUP 2017**

Memorandum Circular No. 2017-166  
December 18, 2017

**1.0 Background**

The Philippine Sports Commission (PSC) of the Office of the President in line with its mandate to promote and develop grassroots sports all over the country, in coordination with the Office of Senator Manny Pacquiao, will conduct the PSC-PACQUIAO AMATEUR BOXING CUP 2017, a nationwide sports program to encourage boxers to develop interest and participate in boxing as a sport. The Boxing Cup is a weekend tournament that will be held around the country to scout potential amateur boxers who can be included in the pool of National boxers.

**2.0 Purpose**

This policy encourages all local chief executives to support the PSC-PACQUIAO AMATEUR BOXING CUP 2017 nationwide competition.

**3.0 Scope/Coverage**

All Provincial Governors, City Mayors, Municipal Mayors, Punong Barangays, DILG Regional Directors, and ARMM Regional Governor, and all other concerned.

**4.0 Policy Content and Guidelines**

4.1 The PSC-PACQUIAO Amateur Boxing CUP 2017 Preliminary Leg will be conducted on December 16-17, 2017 in General Santos City.

4.2 All Provincial Governors, City Mayors and Municipal Mayors are hereby enjoined to extend full support by encouraging and endorsing local boxers, coaches and officials to participate in three major areas:
