SUBJECT : AMENDMENT TO DILG MC NO. 2004-124 SERIES OF 2004, AMENDING FURTHER DILG MC NO. 99-06 DATED JANUARY 7, 1999, ENTITLED, *ULAP ANNUAL MEMBERSHIP DUES*

In consonance with Section 3 of Presidential Executive Order 351, s. 2004, and consistent with ULAP Resolutions No. 2017-15 and 2017-16, rationalizing and increasing the ULAP annual dues from its regular and associate members and annual assessment fees from provinces, cities and municipalities, DILG MC No. 2004-124 s. 2004 particularly paragraph 2 thereof, is hereby amended to read as follows:

As part of the overall efforts to generate funds to finance the Union's programs, projects, and activities and in consideration of the present inflation rate, the General Executive Council (GEC) approved and adopted, during their 5th GEC Meeting held on May 24, 2017 at the Manila Hotel, Ermita, Manila, the following annual membership dues of Provinces, Cities and Associate Members, beginning Calendar Year 2018:
