PROVINCIAL AND HIGHLY URBANIZED CITY SANGGUNIANG KABATAAN (SK) FEDERATION PRESIDENTS AND LOCAL YOUTH DEVELOPMENT OFFICERS (LYDO) SUMMIT AND OATH-TAKING OF THE PROVINCIAL AND HIGHLY URBANIZED CITY SANGGUNIANG KABATAAN (SK) FEDERATION PRESIDENTS TO THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES

DATE:

The National Youth Commission (NYC), the Department of the Interior and Local Government (DILG) and the Dangerous Drugs Board (DDB) will be conducting the Provincial and Highly Urbanized Sangguniang Kabataan (SK) Federation Presidents and Local Youth Development Officers (LYDO) Summit on July 2018. The module and program for the SK Federation Presidents shall be given on July 9-11, 2018 at Hive Hotel & Convention Place at Sct. Tuason St, Diliman, Quezon City. The module and program for the LYDOs shall be given on July 16-18, 2018 at Cocoon Boutique Hotel at 61 Scout Rallos St., cor Scout Tobias St., Brgy. Laging Handa, Diliman, Quezon City.

The Summit aims to discuss the Philippine Anti-Illegal Drugs Strategy (PADS) and the Philippine Youth Development Plan (PYDP) 2017-2022 vis-à-vis roles and functions of Sangguniang Kabataan and Local Youth Development Officers. The objective of the gathering is to consolidate and standardize action plans and to provide monitoring and evaluation procedures that will ensure the full participation of the SKs in pursuing anti-drug priorities of the government.

In this connection, all Provincial Governors, Highly Urbanized City Mayors, and/or their Local Youth Development Officers are enjoined to participate in the said summit and oath-taking ceremony. The travelling expenses and per diem the day prior to said activity is hereby authorized, chargeable against local funds, subject to availability of funds, and to the usual accounting and auditing rules and regulations.
