SUBJECT: ATTENDANCE OF THE LOCAL YOUTH DEVELOPMENT OFFICERS AND 19th SANGGUNIANG KABATAAN **OFFICIALS** TO THE INTERNATIONAL YOUTH DAY

The United Nations Youth Association of the Philippines [UNYAP] has been actively organizing events for the International Youth Day having focused on the Millennium Development Goals [MDGs] and now the Sustainable Development Goals [SDGs] of the United Nations.

This year, UNYAP will be conducting its 19th Year International Youth Day Celebration with the theme "Safe Spaces for Youth", on 11 August 2018 at the Mini Theatre of the University of Makati, Makati City, National Capital Region, with a registration fee amounting to Php 300.00 per participant to cover snacks, lunch and materials for the event.

The payment transportation expenses, hotel accommodation [if applicable] and other related expenses may be authorized in accordance with limitations prescribed in COA Circular No. 2012-003 dated 29 October 2012, and subject to the usual accounting and auditing rules and regulations.
