ATTENDANCE TO THE TRAINING-ORIENTATION ON THE

MEASURES AND INDICATORS IN DECLARING LOCAL

GOVERNMENT UNITS AS DRUG-CLEARED

The Department of Interior and Local Government is implementing a program to further strengthen the local Anti-Drug Abuse Councils (ADACs). This included the signing of Joint Memorandum Circular No. 2018-01 between the Department of Interior and Local Government and the Dangerous Drugs Board which outlines the functionality indicators of Anti-Drug Abuse Councils (ADACs) in all levels of local government. One of the performance measures of Provincial/City/Municipal ADACs is the declaration of their component local government units (LGUs) as drug-cleared. Therefore, this makes it imperative for the Regional Oversight Committees (ROC) to fully understand their duties and functions, and the necessary parameters in declaring a drug-cleared LGU. The ROC is composed of the Philippine Drug Enforcement Agency (PDEA), Department of Interior and Local Government (DILG), Philippine National Police (PNP), Department of Health (DOH), and local chief executives.

In line with this, it is necessary to conduct a nationwide orientation on the drugclearing program, and the subsequent declaration of drug-cleared status, to members of the Regional Oversight Committees. This activity shall be conducted in cooperation with the Philippine Drug Enforcement Agency in their capacity as the Chairman of the Regional Oversight Committees. The training-orientation schedule is as follows:
