CELEBRATION OF 2018 MONTH OF OVERSEAS FILIPINOS AND INTERNATIONAL MIGRANTS DAY

Memorandum Circular No. 2018 - 170.

October 4, 2018

1. Background

Proclamation No. 276 dated June 21, 1988 declares the month of December as the Month of Overseas Filipinos (MOF) and United Nations Resolution No. 55/93 dated February 28, 2001, proclaims December 18 of every year as the International Migrants Day (IMD). The annual celebration is being spearheaded by an Inter-Agency Committee (IAC) for the MOF and IMD, chaired by the President of the Philippines Migrants Rights Watch (PMRW), an umbrella organization of twelve (12) migrant Civil Society Organizations (CSOs) working for the recognition, protection, fulfillment of the rights of Filipino migrants in the Philippines and abroad. The Commission on Filipino Overseas (CFO) is the co-chair of the said committee. The IAC is composed of members and partners from national government agencies, LGU Leagues, private sector and non-government organizations.

2. Purpose

This Memorandum Circular is issued to encourage all local government units to observe the MOF and IMD Celebration in their respective areas of jurisdiction, and make it meaningful by recognizing the migrants and overseas Filipinos' hard work and efforts, sacrifices, and important contributions to national development.

3. Scope and Coverage

All Provincial Governors, City and Municipal Mayors, DILG Regional Directors and Field Officers, ARMM Regional Secretary and all others concerned

4. Policy Content and Guidelines

This year's celebration will carry the theme, "KAALAMAN SA PERA, MAGINHAWANG BUHAY ANG DALA: TOWARDS FINANCIAL LITERACY FOR OVERSEAS FILIPINOS AND THEIR FAMILIES."

Relative thereto, all local government units are enjoined to support the observance of MOF celebration and IMD by coordinating with the concerned agencies for the conduct of fitting activities such as, but not limited, to the following:

- Forum on migration, balikbayan night, sports fest, fun run, food fair, film showing, art exhibits, cultural presentation and similar activities that may be of interest or relevant to migrants and overseas Filipino workers and their families; and
- Cross-sectoral engagements e.g. health fair, free livelihood training, healthy lifestyle session, and other relevant activities.

All DILG Regional Directors, through their respective field officers, are hereby directed to cause the widest dissemination of this Circular and extend the necessary assistance, as may be necessary, to make the celebration more meaningful.
