**TO : ALL PROVINCIAL GOVERNORS AND THE ARMM REGIONAL GOVERNOR, MAYORS OF HIGHLY URBANIZED CITIES (HUC) INDEPENDENT COMPONENT CITIES (ICC) AND MUNICIPALITY OF PATEROS, SANGGUNIANG KABATAAN PEDERASYON PRESIDENTS OF THE PROVINCES AND HIGHLY URBANIZED AND INDEPENDENT COMPONENT CITIES, DILG REGIONAL, PROVINCIAL AND CITY DIRECTORS AND ALL OTHERS CONCERNED**

**SUBJECT : 12<sup>th</sup> NATIONAL YOUTH PARLIAMENT**

The National Youth Commission (NYC) will hold its **12th National Youth Parliament (NYP) on October 21-25, 2018 in Davao City**. NYP is a biennial congress of youth leaders convened to formulate policy recommendations that address pressing issues and concerns that affect the youth sector. It provides a platform for youth leaders to share ideas and gain valuable insights while engaging in debates observing parliamentary rules and conduct. The output of the activity will serve as the government's guide in policy formulation and development concerning the youth.

In this connection, all Sangguniang Kabataan Pederasyon Presidents of the Provinces, Highly Urbanized Cities (HUCs), Independent Component Cities (ICCs) and the Municipality of Pateros are hereby encouraged to attend the said activity. In case the SK Pederasyon President is unable to attend, an authorized officer of the Pederasyon may attend as representative.

The NYC shall shoulder the food and accommodation of all the delegates for the duration of the parliament and shall not collect any registration fees. Transportation and other incidental expenses shall be shouldered by the participants, chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations.
